Tyson Foods trimmed its full-year revenue forecast, in a sign that price hikes and stubbornly high inflation are discouraging consumers from spending on its products.

KKR posts 26% drop in Q1 earnings, beating expectations

KKR said its after-tax distributable earnings fell 26% year-on-year in the first quarter due to a sharp drop in asset sales from its private equity portfolio and lower transaction fees.

BEFORE THE BELL

Futures for Canada's resources-heavy main stock index rose, tracking strength in crude prices. **U.S. stock index futures** edged higher ahead of key inflation data expected in the week that would offer more cues on the Federal Reserve's monetary policy path. **European shares** rose, with energy and bank stocks leading the way. In Asian equities, **Japanese shares** ended lower as investors sold stocks as the **yen** strengthened against the dollar and concerns over the U.S. banking sector persisted. **Gold** prices ticked up as the **U.S. dollar** eased.

STOCKS TO WATCH

AltaGas Ltd & Enbridge Inc: AltaGas named Enbridge's Vern Yu as the company's next president and CEO, effective July 1, 2023. Yu will succeed Randy Crawford, who has been AltaGas CEO since 2018. Yu is joining AltaGas after a three-decade stint with pipeline operator Enbridge, where he most recently served as executive vice president of corporate development, chief financial officer and as president of its New Energy Technologies segment.

U.S. electric-vehicle startups set for another quarter of steep cash burn

U.S. electric-vehicle startups are expected to report another quarter of dwindling cash reserves next week, piling pressure on a group of companies that are struggling to ramp up production and have few options for funding in a turbulent economy.

ANALYSTS' RECOMMENDATION

- Altus Group Ltd: Scotiabank cuts target price to C\$59 from C\$69, after the company reported weaker-thanexpected first-quarter results in its Altus Analytics business as bookings were down and recurring revenue was flat.
- Andlauer Healthcare Group Inc: Scotiabank cuts target price to C\$52 from C\$55, after the company's first-quarter results missed expectations due to the normalization in U.S. truckload premium pricing.
- **George Weston Ltd**: Scotiabank raises target price to C\$183 from C\$181, following the recent results and estimate update from the company's two operating segments; Loblaw and Choice Properties.
- Transalta Renewables Inc: ATB Capital Markets cuts target price to C\$14 from C\$15.5, as the company's first-quarter results missed market expectations and cited near-term cash tax headwinds.
