· Coca-Cola raises annual sales, profit forecasts on steady demand

Coca-Cola raised its annual organic sales and profit forecast, signaling strong demand for the beverage giant's sodas, energy drinks and juices in its U.S. and international markets.

• GM beats second-quarter expectations, raises forecast again

General Motors reported second-quarter profit and revenue that beat Wall Street's expectations, and raised its annual profit forecast for a second time this year, buoyed by strong pricing and demand for gas-powered trucks.

United Parcel Service missed Wall Street estimates for second-quarter earnings, hurt by subdued package delivery demand and higher costs from its Teamsters labor contract.

• GE Aerospace lifts 2024 profit view on strong demand for engine parts, services

GE Aerospace raised its annual profit forecast on strong demand for its aftermarket services, including jet-engine parts, as a shortage of new planes prompted airlines to keep older ones in the air.

Cybersecurity firm Wiz calls off \$23 billion deal with Google, memo says

Israeli cybersecurity startup Wiz has ended talks with Google-parent Alphabet on a reported \$23 billion deal in which it would have become the U.S. tech giant's largest-ever acquisition, according to a Wiz memo seen by Reuters.

BEFORE THE BELL

Futures linked to **Canada**'s **main stock index** were subdued as a decline in **crude** prices offset the gains in **gold**, while investors kept a tab on the Bank of Canada's monetary policy meeting due on Wednesday. **U.S. stock index futures** slipped as investors awaited earnings reports from major tech companies due later in the day, which will be analyzed to determine if the market's recent record highs can be maintained. **European shares** edged higher, with a rally in technology-related shares offsetting losses in miners. **Japan**'s **Nikkei** ended marginally lower, extending its losing run to a fifth consecutive session, as caution over a strengthening yen overshadowed gains in chip stocks. The **U.S. dollar** held steady against a basket of currencies.

Some of the staff at Elon Musk's Neuralink are making preparations to sell the brain implant company's stock in the wake of its valuation jumping following its first human trial, according to people familiar with the matter.
